**NOTICE OF AMENDMENTS TO
SCHEDULE OF FORMER POSITION HOLDER CLAIMS**

PLEASE TAKE NOTICE that on September 6, 2018, Alan M. Jacobs, the Creditors' Trustee, filed his Schedule of Former Position Holder Claims ("Former Positions Schedule") on the Official Docket [Docket Nos. 4186 and 4187].¹

The Former Positions Schedule sets forth each Former Position Holder with a claim based on an investment contract with Life Partners relating to a Fractional Position in a Policy, but **which investment was no longer held by the Former Position Holder as of the Subsidiary Petition Date (May 19, 2015)**, or as to which the holder is otherwise deemed to be a Former Position Holder under the Plan. As ordered by the Bankruptcy Court, the claims of Former Position Holders are allowable in the amount of each holder's "Net Cash Loss", if any, resulting from each such former investment position it held. **The Former Positions Schedule DOES NOT impact Position Holder Trust interests or current interests in investment policies that are held by investors.**

¹ Capitalized terms used and not otherwise defined in this Notice have those same definitions as are set forth in the *Revised Third Amended Joint Plan of Reorganization of Life Partners Holdings, Inc. et. al., Pursuant to Chapter 11 of the Bankruptcy Code* [Docket No. 3427] ("Plan").

Pursuant to certain procedures approved and entered by the Bankruptcy Court on August 31, 2018 [Docket No. 4182], the Creditors' Trustee has conferred with claimants who formally and informally objected to the Former Positions Schedule, in order to attempt to resolve such objections and informal objections.

Pursuant to those efforts, the Creditors Trustee hereby files this Notice of Amendments to the Former Positions Schedule, which amendments are set forth in **Exhibit "A"** attached hereto and incorporated herein by reference for all purposes. **Only those claimants whose interests have been impacted by amendments to the Former Positions Schedule are shown on Exhibit "A"**. If your name appears on Exhibit "A" with any Funding ID marked "Deleted" and the corresponding dollar amount stricken out, this means that the previously listed Former Position has been removed from the Former Positions Schedule. If your name appears on Exhibit "A" with any Funding ID marked "Added", this means that an additional Former Position has been added to your claims under the Former Positions Schedule, in the corresponding amount shown. Funding IDs (and corresponding dollar amounts) that are shown as neither "Added" or "Deleted" constitute information from the original Former Positions Schedule that has not changed. Any claimant who does not appear on Exhibit "A" has not been affected by any amendments to the Former Positions Schedule since the original time of its filing.
